Welcome

- I. **Welcome & Conflict of Interest Statement** Mr. Kevin Austin welcomed those in attendance, reviewed the agenda, opened the meeting, and read the conflict of interest statement. Mr. Austin noted a conflict of interest and his intent to abstain from voting on P6.0 highway project approval.
- II. **Public Comment** Mr. Jesse Day introduced Mr. Carter Spradling as the new Northwest Piedmont RPO Coordinator.

Other Business – Agenda items IX – XV were covered as discussion items while TAC members joined the call.

- IX. **Division 9 Update** – Mr. Phillip Craver provided a verbal report.
- X. **Division 11 Update** – Mr. Rob Weisz provided a verbal report.
- XI. **RPO Update** – Mr. Carter Spradling provided a verbal report.
- XII. **TPD Update** – Mr. Reuben Crummy provided a verbal report.
- XIII. **BOT Update** – Mr. Tullie Carlton provided a verbal report.
- XIV. **New Business** – No update was provided.

Action Items

- III. **February 18, 2020, Meeting Minutes** Mr. Austin shared the meeting minutes with the group. Mr. Van Tucker made a motion to approve the minutes from the February 19, 2020, meeting and Mrs. Monta Davis-Oliver seconded the motion. The motion passed unanimously.
- IV. **FY 2020-2021 Planning Work Program** Mr. Jesse Day presented the proposed fiscal year 2020-2021 Planning Work Program. Mr. Van Tucker made a motion to approve the PWP, meeting and Mrs. Monta Davis-Oliver seconded the motion. The motion passed unanimously.
- V. **Regional CTP / Endorsement of Socioeconomic data** Mr. Jesse Day presented the gathered socioeconomic data for the pending Comprehensive Transportation Plan. Mr. Van Tucker made a motion to endorse the CPT data and Mrs. Monta Davis-Oliver seconded the motion. The motion passed unanimously.
- VI. **P6.0 Submission List** Mr. Jesse Day presented the list of proposed projects to be submitted to NCDOT for state funding. Mr. Phillip Craver and Mr. Rob Weisz provided context about specific projects. The TAC agreed to allow Pilot Mountain to substitute a greenway project for a sidewalk project if appropriate. Two additional projects (H170327 & H191169) were left off of the submission list, but approved for inclusion. A roundabout project in Elkin was removed from the list. Mr. Van Tucker made a motion to approve the P6.0 submission list, and Mrs. Monta Davis-Oliver seconded the motion. Mr. Kevin Austin abstained from the highway vote due to conflict of interest. The motion passed unanimously.
- VII. **Proposed Schedule of Dues** Mr. Jesse Day presented a proposed schedule of dues for the upcoming 2020-2021 fiscal year including both county and municipal dues. Mr. Van Tucker made a motion to adopt the schedule, and Mrs. Monta Davis-Oliver seconded the motion. The motion passed unanimously.
- VIII. **FY 2019-2020 Planning Work Program Amendment** Mr. Carter Spradling presented a proposed amendment to the budgeted items from the 2019-2020 PWP. Reallocation of funds from travel and training to prioritization and planning. Mr. Van Tucker made a motion to approve the amendment, and Mrs. Monta Davis-Oliver seconded the motion. The motion passed unanimously.
