Chairman Kevin Austin welcomed the PTRC Board of Delegates and called the meeting to order at 12:00pm via Zoom and in person attendance. Mr. Austin welcomed Mayor Lewis Dorsett as the new delegate for Archdale. Chairman Austin requested a moment of silence and then led the Board in the Pledge of Allegiance.

- 1. Presentation: NC Task Force for Racial Equity in Criminal Justice, Ms. Jasmine McGhee, Special Deputy Attorney General, Department of Public Safety
 - a. Ms. Jasmine McGhee stated that the NC Task Force for Racial Equity in Criminal Justice (TREC) was formed to address systemic racism. This task force was formed through Executive Order 145 in June 2020.
 - b. Black adults in the US are 5.9 times as likely to be incarcerated and twice as likely to be pulled over for a traffic stop as white adults. They are also more likely to be jailed before trial.
 - c. TREC is comprised of a diverse cross section of leaders across NC that include advocates, elected officials, judges, prosecutors, public defenders and law enforcement.
 - d. Six listening sessions to hear from community leaders and three two-hour public comment sessions were held to form the final report which can be found here: www.ncdoi.gov/trec
 - e. Going forward there will be quarterly meetings, monthly implementation committee meetings, and TREC learning sessions. They came out of this process with a report of 125 recommendations which was released in December 2020.
 - f. Some of the local policy recommendations for local law enforcement include: improving policing practices and revise use of force standards; reform investigations; and reinvesting in communities and strengthen community policing and reimagining public safety and reinvest in communities
 - g. Local government recommendations include: promote local public safety and wellness solutions in schools and communities.
 - h. Recommendations for court solutions include: reimagine public safety using restorative justice and equity for victims and survivors of crime; reduce school to prison pipeline and increase racial equity in the juvenile justice system; reduce the number of offenses in the criminal code; improve pre-trial release and bail practices; make criminal trials fairer; promote racially equitable prosecutorial practices; addressing sentencing and incarceration disparities; amend prison programming; and reduce collateral consequences of criminal convictions.
 - Mr. Kevin Austin stated that the NCACC just passed a resolution supporting the work of Ms. McGhee's committee. The Public Steering Committee is working on recommendations for counties.
 - j. Mr. Matt Reece asked about structured sentencing and the effects of flexibility being given to the bench. Ms. McGhee responded that this is an important and complex issue. The Commission is currently doing a study on this and recommendations will be forthcoming.
 - k. Ms. Lynne DeVaney expressed her concerns about at risk children and how to redirect their behavior and opportunity. Ms. McGhee stated that there is huge power in youth diversion. Her committee would love to see every school have a School Justice Partnership. - Ms. McGhee also stated that something you can do right now. There is currently a bill to raise minimum age of juvenile jurisdiction. You can reach out to your representatives to express your support for this Senate Bill 207. NC has the lowest age of juvenile in the country.

6. Around the region

- a. Ms. Stephanie Blair, Representative from Senator Thom Tillis' office, announced that he Senate passed the Infrastructure package. This includes \$7.2billion for roads and highways, \$11million for public transportation, \$457million for bridge construction, \$440 for clean water, and \$100million for broadband. The Senate also passed the Budget Resolution. Legislative action is needed by the fall to keep us from defaulting on our debt. If you have any friends or family in Afghanistan, direct them to our offices so we can help. Also, when applying for EDA federal loans let us know so our senators can send support letters.
- b. Mr. Mike Fenley, Representative from Richard Burr's office, added that the House will return from recess after Labor Day. At this time they will take up the Infrastructure package and Budget Resolution.
- c. Mr. David Fernandez announced that they will be hosting the Randolph County Elected Officials gathering the first Tuesday in November.
- d. Mr. Homer Dearmin invited everyone to King Fest on October 2nd. There will be food, music and vendors.
- e. Ms. Marikay Abuzuaiter invited everyone to the NC Folk Festival in Greensboro September 10th-12th.
- f. Mr. Kevin Austin announced the Yadkin County Harvest Festival on September 11th.
- g. Mr. George McClellan invited everyone to RidgeFest September 9th-11th.
- h. Mr. Sam Bishop announced Surry County's 250th Anniversary celebration this Saturday. There will be music, food and a car show. On September 25th the Annual Pumpkin Festival will be in downtown Elkin.
