I am writing this letter to express strong support for the Yadkin River Greenway project submitted by the Piedmont Triad Regional Council for the **Multimodal Project Discretionary Grant** program. This project, anchored by a new pedestrian bridge plus other network improvements, will create a needed connection between the towns of Elkin and Jonesville and multiple existing trail systems, including three federal/state sanctioned trails.

NCDOT is committed to providing an efficient multi-modal transportation network in North Carolina so that the access, mobility, and safety needs of all users of all ages and abilities are safely accommodated. This commitment has led to the administration of several recent planning efforts in Yadkin River Greenway project area, including the Elkin Bicycle and Pedestrian Plan, Jonesville Pedestrian Plan, and Yadkin Valley Regional Bicycle Plan. These local and regional planning efforts, as well as other statewide planning efforts, such as the Great Trails State Plan, have produced recommendations for developing connected transportation networks in the project area and demonstrate strong local interest and support in creating more responsive mobility options.

If awarded, construction of a pedestrian bridge would provide safe walking and biking connections between the towns of Elkin and Jonesville that have not existed since the Hugh Chatham Bridge was removed almost 20 years ago. Reestablishing this connection and connections to neighboring transportation facilities will enhance mobility options, increase safety, enhance economic opportunities and encourage healthy lifestyles. This project will also improve transportation conditions in an area exhibiting potential indicators of transportation disadvantage, such as higher rates of poverty and zero-vehicle households in comparison to the overall state.



Citizens and visitors alike to the area will benefit from the pedestrian bridge project linking Elkin and Jonesville. The positive impact from this connection across the Yadkin River will undoubtedly improve quality of life by providing opportunities for transportation, recreation, public health, economic development, and environmental stewardship.
