1:15 Guest Speaker: Jenn Palmer and Christopher Gergen, 4P Foods

 4P Foods is a wholesale food distributor directly connecting farmers to restaurants, hospitals, universities, etc. Good connections with Elon, High Point University, and UNC-Chapel Hill. They are planning an event in Caswell County on June 6th (10am-12pm) at Co-Square space in Yanceyville and with chefs at Elon, connecting Piedmont Progressive Farmers Coop with chefs. Aramark recently awarded PPFC with a grant to expand their operations. Presentation on 4PFoods and the work they are doing in the Triad (part of this is direct to consumer sales and wholesale). Food council is invited to attend, send email Jennifer by May 31st if you'd like to attend.

1:30PM Council Member Updates

Gary, from SHARE Harvest Market, turned in USDA GusNIP grant for Food RX and feeling hopeful. Project start date if awarded will begin October 1, 2023. Last week, BCBSNC was there for site visit and group meeting and went well.

Extension- Walnut Cove Farmers Market opening next week (runs Thursdays from 11am-1pm) and popup markets before concert series. Still looking for vendors: https://stokes.ces.ncsu.edu/stokes-county-small-farms-horticulture/walnut-cove-farmers-market/

Courtney- Glow House Ag is working on Ray Warren Project with Housing Authority in Greensboro as well as putting in community garden at Hall Tower on N. Church Steet. Stay tuned for grand opening! Ongoing they are offering garden and cooking classes with chefs.

Samira asked who would maintain garden on regular basis. Garden Club will maintain with monthly upkeep from Glow House. If they ever need education for children, Recipe 4 Success is available, though Hall Tower is older adults. Glow House is working with 17 properties so there may be other opportunities.

Jan Jones, Director of Public Policy, Second Harvest Food Bank- in policy, things are really happening now. Watching debt ceiling negotiations and asking folks to reach out elected officials in DC. A proposed plan expands work requirements for food aid to older adults age 55; this means about 270K anticipated to lose benefits and coupled with emergency benefits ending, it will impact households and retailers. Second Harvest recently received grant from Feeding America from Elevating Voices: Power Summitsending a person with lived experience to DC for 4 days/3nights to meet with others with lived experience and share stories and priorities for Farm Bill. Renee Wisely from Second Harvest who has lived experience was selected in a competitive process.

Attended Anti-Hunger conference earlier this month.

Expanding medically tailored meals program, working with Atrium Wake to work with patients with hypertension, renal disease, and sending meals.

Farm Fresh Nourish has kicked off working with local growers. Looking for additional growers to participate this year and next to get meals to those seeking food assistance.

Rachel Zimmer, healthcare provider Atrium Wake Forest Baptist Health- recently integrated with new national organization, Aurora Health, and building a new department. Huge undertaking to develop strategy around addressing community health in a more equitable way.

Food RX research program is running, finish enrollment by the end of the month. Does not plan to expand due to other obligations. Also working with Gary and SHARE to get mobile health program patients enrolled into their program.

Working with Food Research & Actions Center (FRAC) to complete a national survey of healthcare providers across the nation who provide care for older adults to determine their comfort with assessing and addressing food insecurity in clinical setting. June 1st they will begin mandatory screening patients for social risk factors in whole health system. Rachel is worried that capacity isn't there to meet the need of what they will find in clinical settings. Thinking about this strategically over the last few months.
