ARPA funds provide a unique opportunity to consider needs and service delivery that have the potential to respond to unmet needs of older adults and family caregivers. The PTRC AAA is taking a regional approach in distributing these funds-based on the priorities established by the North Carolina Division of Aging and Adult Services.

The PTRC AAA made ARPA Transportation Services Grants available in the amount of up to \$150,000 each in all twelve counties. ARPA Transportation Services Grants are intended to assist older adults who cannot provide or arrange their own transportation with maintaining or regaining the ability to live and function as independently as possible by providing transportation to locations, including crossing lines for medical trips, which enable older adults access services and/or carry -out essential daily living tasks. These funds are available to transportation authorities, county entities, or already established contracted partners of PTRC.

ARPA funds provide a unique opportunity to consider needs and service delivery that have the potential to respond to unmet needs of older adults and family caregivers. The PTRC AAA is taking a regional approach in distributing these funds-based on the priorities established by the North Carolina Division of Aging and Adult Services.

The PTRC AAA made seven ARPA grants of \$45,000 each available for NC Caregivers – Information and Program Marketing Promotion. Four agencies were awarded grants.

The goals of the Family Caregiver Support Program are for caregivers to: be empowered through education; be informed of services available to them that can support their own well-being; and be connected to a support system that can help reduce their level of stress, social isolation, and caregiver burden. Awarded grantees will advance the visibility of the Family Caregiver Support Program (FCSP) within the Region to family caregivers with the objective of increasing the number of family caregivers accessing the program. In addition, grant awardees will engage in specific activities to build new partnerships on behalf of family caregivers and reach new family caregivers who have not been served by the FCSP in the past.

RE: Approving \$10,000 in grant funding from Visit High Point

The Regional Planning Department has applied for and received a \$10,000 grant from Visit High Point made available in the organization's year-end grants cycle. The destination management and marketing organization announced a one-time grants program at the end of their fourth fiscal quarter ending June 30th for projects that promote tourism and economic development.

Grant funds will be used to pay for targeted, High-Point-centric ad campaigns on Meta platforms and in Google Search campaigns promoting content via NCTriadOutdoors.com. Detailed geographic and demographic data from these campaigns will inform a tourism strategic planning, research and development project with two primary goals: 1) support Visit High Point with data and research into the role outdoor recreation plays into High Point's tourism economy, and 2) leverage NCTriadOutdoors.com and its social media as a regional asset enhancing the outdoor recreation economy and outdoors tourism in the PTRC region.

The grant project runs through December 2023 and has a \$10,000 in-kind match from staff time creating online content, conducting surveys, and compiling a final report.

ACTION REQUESTED:

The PTRC Regional Planning Department requests that the Executive Committee authorize staff to receive \$10,000 in funds from Visit High Point and administer the funds towards Meta and Google Search campaigns.

RE: Multimodal Discretionary Grant Application in Surry and Yadkin Counties

The PTRC planning department requests to apply for and if successful receive up to \$25,000,000 from the US Department of Transportation for planning and construction funds for bicycle and pedestrian infrastructure in Jonesville and Elkin, located in Yadkin and Surry Counties respectively. The Multimodal Project Discretionary Grant (MPDG) has a stated goal of "improving and expanding the surface transportation infrastructure in rural areas." Specifically, the proposal includes linking the towns of Elkin and Jonesville via construction of a bicycle and pedestrian bridge over the Yadkin River in addition to sidewalk, side path, and greenway construction and/or expansion throughout the two communities.

About the Grant

The Multimodal Project Discretionary Grant common application (MPDG) provides Federal financial assistance to highway and bridge, intercity passenger rail, railway-highway grade and separation, wildlife crossing, public transportation, marine highway, and freight and multimodal projects, or groups of such projects, of national or regional significance, as well as to projects to improve and expand the surface transportation infrastructure in rural areas. The Department seeks to:

- 1) Fund projects under the MPDG common application that reduce greenhouse gas emissions and are designed with specific elements to address climate change impacts
- Award projects under the MPDG common application that address environmental justice, particularly for communities (including rural communities) that may disproportionately experience consequences from climate change and other pollutants.
- Award projects under the MPDG common application that proactively address equity and barriers to opportunity, including automobile dependence as a form of barrier, or redress prior inequities and barriers to opportunity.

ACTION REQUESTED:

The PTRC Planning Department requests that the Executive Committee authorize staff to apply for and receive \$25,000,000 in funds from the US Department of Transportation and administer the allocation of said funds. The request addresses the 80% share of project expenses to be paid by the federal government. The other 20% of match is being sought through local and State efforts. The geography associated with the project is along the banks of the Yadkin River in Elkin and Jonesville and an expansion of bicycle and pedestrian facilities into southeast Jonesville.

<u>Alamance County Planning Support:</u> The Regional Planning Department requests to enter into contract with Alamance County to provide planning support for an estimated two months while the County searches for a planning director. The services will focus on larger and more technical development proposals to ensure watershed, floodplain, subdivision and other local and State regulations are followed with ongoing and forthcoming development proposals.

ACTION REQUESTED:

Request for approval to enter into contract providing professional planning services from *August 1 to September 30, 2023 to Alamance County for at least \$7,200*. Hours over and above 80 hours over the two months will be billed at a per hourly rate.

<u>Mayodan LDP</u>: The Regional Planning Department requests to enter into contract for planning services with Town of Mayodan to update and create a new and improved Land Development Plan (LDP) with the following scope: Map and Analyze Existing Conditions, Public Involvement and Consensus Building, Land Development Report and Maps and Plan Review and Adoption. The updated Land Development Plan will allow the Town of Mayodan to identify a vision for future growth rooted in community input for several years in the future, building on the assets and investment taking place in and around the Town.

ACTION REQUESTED:

Request for approval to enter into contract providing professional planning services from *March 2024 to February 2025* with the **Town of Mayodan for \$37,250**. The Town approved the contract amount at their June Council meeting.

<u>Pleasant Garden LDP:</u> The Regional Planning Department requests to enter into contract for planning services with Town of Pleasant Garden with a similar scope of services above for the Town of Mayodan. The unique vision of Pleasant Garden will be based on the community input from Pleasant Garden citizens and utilized into the future growth plan for the Town.

ACTION REQUESTED:

Request for approval to enter into contract providing professional planning services from *January 2024 to December 2024* with the **Town of Pleasant Garden for \$37,500**. The Town of Pleasant Garden has signed an agreement letter.

<u>Yadkin Riverkeeper:</u> The Regional Planning Department created a Yadkin River State Trail Map both in print and online for the Yadkin Riverkeeper. The ongoing hosting and maintenance of the online mapping site utilizes PTRC's ARCGIS online mapping system. There is an annual cost to the license and maintenance of the system. We are requesting support from the Yadkin Riverkeeper to maintain the site and provide hours for collection of field data or map updates throughout the year.

ACTION REQUESTED:

Request for approval to enter into contract with the **Yadkin Riverkeeper for \$5,000** from *July 2023 to June 2024* to host online map and provide up to 20 hours of field work or GIS maintenance services over and above the maintenance of existing data for hosting services.

Monitoring Report PTRC Yadkin County ESFRLP1918

Progress of Projects:

ESFRLP1918: Under the original ESFRLP19 Application for Funding, a total of five units in Yadkin County (ESFRLP1918) were targeted for assistance. Per the most recent information in our electronic files, two units were set up by December 31, 2022, the target date to complete reservations per the revised funding agreement. One of these units made it to loan closing and moved into the rehab process. It is now completed, with any remaining administration to be complete by June 30, 2023 or shortly thereafter. Congratulations are in order for completing this one unit, despite the Covid pandemic protocols, material shortages, and price increases. This unit has been marked as completed in our system; all invoices have been requisitioned and reimbursed for this unit. The CCFC was submitted on 12/22/22, before the proposed extended closeout date for this project. Please remember to send your homeowner success story to Mark Lindquist as soon as practicable as we cannot close this project without it.

Discussion with Designated Recipient Member

Before the in-home monitoring visit, and after, I consulted with John Quiros, a project manager for some ESFRLP Projects, now for special construction projects. Ms. Tonya Spencer was the original Project Manager assigned to this project. Mr. Darryl Anderson was assigned when the project was ready to start. Mr. Quiros was available for this required Monitoring visit and substituted in as Mr. Anderson is no longer with PTRC. I appreciated the openness and the time allowed to candidly discuss the ESFR program as it specifically relates to Yadkin County. While the monitoring visit was somewhat later than initially expected due to state regulations for pandemic protocols, this home visit was successful as I was able to see the previously completed work in person and with the submitted photos, and to talk with the homeowners that were available.

Compliance with Program Guidelines

Policies and Procedures

PTRC's Assistance Policy and Procurement and Disbursement Policies for Yadkin County were once again reviewed before my visit. The policies as written appear to be more than adequate to govern the administration of the project under typical circumstances. They also included the added protocols for visitation and construction due to the Covid-19 pandemic.

Case File Review

The case file (Allan B. King) was reviewed at the NCHFA office before my visit, using our desktop monitoring procedure under the direction of Mark Lindquist, Senior Program Compliance Coordinator. The files were detailed and organized well. The review turned up no significant discrepancies or missing documents.

INFORMATIONAL ITEM CONTINUED

Monitoring Report PTRC Yadkin County ESFRLP1918

Inspection of Dwelling Unit

John Quiros accompanied me to the King home. It was inspected for work completed per Mr. Anderson's work write-ups based on the ESFRLP Essential Property and Rehabilitation Standards. The work write-ups were very clear and detailed well, especially for a house that was built in 1917.

King:

- 1. The Work Write-up initially stated to construct the handicap ramp using ADA standards, but that was later changed. A change in the Neighborly software will clarify this under future projects. The ramp was constructed using the 'NC Building Code for Residential' standards, and better. There were no toe boards on the newer, second ramp but because the ramp width was 4' instead of the minimum 3', they were not required.
- 2. Bifold doors were used for the closets in the middle right side bedroom. Per our rehab standards under ESFR, these doors are not generally allowed. A waiver request was approved to use these doors since there was no room for regular passage doors.

Final Comments

The King family was at home and very welcoming. Ms. King expressed the family's gratefulness and thankfulness for an excellent job and for the additional accessibility provided for her husband Allan. She expressed that everyone, from the contractors to the PTRC staff, were 'wonderful to work with.'

We thank you once again for participating in the Agency's housing rehab programs. We commend you for continuing to have housing repairs made available to homeowners with most extensive needs throughout your service area. We look forward to working with you under future projects.
