

January to December 2022

- Durham County re-joined, October 2022, per guidance of updated permit; UCFRBA is now 20-members (local gov't/private industry)
- No new monitoring stations; currently Meritech monitors
 41 stations
- Officers changed as of July 1, 2023 (Chair, Elijah Williams & Vice-Chari, Charlie Cocker)
- Siler City remains in UCFRBA despite Removal of Monitoring Waiver
- Held 1st in-person meeting since Covid restrictions at Elon University and City of Greensboro Waste Reclamation Plant; decided to meet twice in person & twice remotely
- 2022 Presentations: Durham Stormwater use of UCFRBA data; update on Jordan Lake Rules stakeholder process & timeline; Cape Fear River Assembly presented on Cape Fear River Basin plan update/process & survey



- Year (1) 9/1/23 to 6/30/24; Year (2) 7/1/24 to 6/30/25; Year (3) 7/1/25 to 6/30/26
- Sampling Services :
 - Technician, Transportation, Administration, Equipment
 - 17 sampling events at 41 monitoring stations
 - Field parameters
 - Analytical parameters (TSS, Phosphorus, Turbidity, Fecal coliform, TKN, Ammonia, Nitrogen, Nitrate/Nitrite, Nitrogen)
 - Notification of abnormalities to PTRC/TJCOG + NCDEQ/DWR Coalition Coordinator
