RE: Renovation – New Training Facility

This item involves fund allocation for up fit of the newly acquired training facility.

The newly acquired church property behind our headquarters building will provide meeting space for our energy efficiency training programs and additional office space to alleviate some of the stress of overcrowding in our Carrollton Crossing facility.

Staff used an RFP to invite bids for the renovations of the basement, which will create 9 offices. The RFP was sent to several private contractors in the region. After two attempts three proposals were received. Based on the cost and an evaluation of the ability of the bidders to complete quality work in a timely manner, staff recommends the following contracts for approval.

Green Serve - \$38,700

This contract is to replace flooring throughout the basement, install a drop ceiling throughout the basement, and construct walls for the offices, and replace decaying windows. Green Serve is the low bidder for the work.

All Systems Restored - \$14,571.88

This contract is to replace all the lighting in the basement, install new lights in the new offices, bring emergency lighting up to current code, install/ repair exterior electrical fixtures for signage and tiny house, and wire all the new office spaces. All Systems Restored is the only bidder that responded for this work.

All Systems Restored - \$12,673.12

This contract involves renovation and expansion of the heating and air conditioning system to meet the needs of the renovated floor plan. All Systems Repaired is the only bidder that responded for this work.

The funding for these projects is from fund reserves in the weatherization program and is unencumbered and available immediately.

RE: Sole Source Bids on Rehabilitation Projects

The PTRC Community Development Department Single Family Rehabilitation Program is currently underway in all of our ESFR Counties (all PTRC counties with the exception of Forsyth County). However due to rising costs of supplies, rises in gas prices and the distance of some of our Counties from the general location of our approved contractors, we have run into issues with contractors attending our pre-bid conferences and thereby, issues with receiving enough bids to complete rehabilitation on many of the approved units.

While we send invitations to bid to all 20 of our approved contractors, we may have only a few show up to bid, and even then, may not get any bids. We have surveyed our contractors to find out some of the reasons for not bidding and those responses are consistent with our opening comment.

The department is requesting permission to allow one bid projects to complete this type of essential work for low income homeowners. Failure to approve one contractor bids will result in the work not getting completed and the homes will continue to deteriorate.

Community Development staff has proposed an amendment to the PTRC Section 8 Administrative Plan, specifically focusing on enhancing the denial process related to applicants with a criminal background or sex offender status.

Recognizing the importance of maintaining a safe and secure housing environment, the proposed amendment aims to refine the criteria and procedures for evaluating applicants with criminal and sex offender histories. The objective is to strengthen the denial process while ensuring compliance with fair housing laws.

The amended and added language on page 3-25 section 3-III.D. SCREENING:

"Denied applicants seeking reconsideration must submit a written request detailing their criminal history or sex offender status, along with any supporting documentation, to the Section 8 office within 10 days of receiving the denial letter. The PHA will acknowledge the receipt of such requests and conduct a thorough review, taking into account the nature, severity, and recency of the offenses. The decision of approval or continued denial will be communicated in writing to the applicant, ensuring transparency in the process. Applicants have the right to appeal a denial, and any updates to the policy will be implemented after approval from the PTRC Section 8 Executive Board, maintaining compliance with fair housing laws and fostering a fair and inclusive housing assistance program."
