


The older adult population (65+) is growing faster than the total population.

Percent Older Adults 19.0%









The <u>Randolph Senior Adults Association</u> serves as the lead senior services agency in the county, with support from the Area Agency on Aging for Home Delivered Meals, Family Caregiver Support Program, Information/Options Counseling, & many other services. It also provides referrals to other senior service providers in the county.

Between 2013 and 2023, Medicare enrollment increased by **21**%, and prescription drug enrollment increased by **31**%, mainly due to the large increase in Medicare Advantage Plans.
