5) Remote Meetings Update

- a. There was a recent Coates' Cannon Post about Emergency meetings and remote meetings.
- b. The biggest takeaway is "Governing boards that want to continue allowing remote participation in meetings should ensure that there is an in-person quorum. They should also be very hesitant to pass measures using remote votes, although this may be less risky if the remote votes have no impact on the outcome. While this case was about a county governing board, the court's reasoning could be applied to city governing boards and even appointed boards alike. Remote meetings continue to be an area to exercise caution."
- c. We have been allowing remote participation but going forward you won't be counted towards our quorum unless you are physically present.

- d. We currently have 77 members so that requires a 39-delegate quorum so we encourage you to come join us in person.
- e. Mr. Dolge will communicate this to all members via email.
- f. We will discontinue roll call votes and rely on the voice vote of those in person. We encourage your participation in discussion regardless of how you join. The impact of this is Roberts Rules of Order will apply to those in person.
- g. According to our Charter (Section 7c), if a quorum is not reached, "action may nevertheless be taken upon any questions which can be decided by an affirmative vote of two-thirds of the delegates as above referenced, if such action shall be supported by the same absolute number of delegate votes as would be required for action at a meeting at which a quorum is assembled."
