2) Presentation: Andrea DeSantis, PhD, Assistant Secretary for Workforce Solutions, NC Department of Commerce

- a. Ms. Andrea DeSantis thanked PTRC for being tremendous partners. We couldn't accomplish our mission without our partners. Their mission is simple: we help people in NC find jobs.
- b. To accomplish that, we administer a statewide system of workforce programs that prepare North Carolinians for employment.
- c. We offer services for adults, veterans, youth, and more. We help employers find the qualified talent they need to make their businesses thrive. To maintain the quality of all those services, we train our state's workforce professionals.
- d. North Carolina is at the forefront for Economic Development. We were named one of the best states to do business.
- e. Being here on Juneteenth is important because we commit ourselves to an economy that works for all citizens regardless of background.
- f. We see a lot of growth in transitioning to a clean energy economy thanks to the groundwork Governor Cooper has put in place. We are excited about the new opportunities to improve both the environment and the state's economy.
- g. Moving forward we will focus on Reentry. We want those who have been incarcerated to have access to services and all the supports they need to be successful back in population. We believe this will only build stronger communities.
- h. Workforce Solutions is working to create a job seeker system for those on Medicaid benefits.
- i. We have business services at the state level to support business engagement.

j. In closing, it's so important to see the power of the workforce system and the power of what you can accomplish. We strive to help communities be successful.

- c. WHEREAS, the Town Council affirms the benefits of cooperation among local governments within a region and their elected and appointed officials;
- d. NOW THEREFORE BE IT RESOLVED by the Town Council of the Town of Swepsonville that the attached Charter of the Piedmont Triad Regional Council is hereby ratified and that membership in the Piedmont Triad Regional Council for the Town of Milton is hereby authorized.

6) Action Item: Request for Approval of Original Budget Ordinance for FY 2024-2025, Mr. Jarrod Hand, Finance Director

- a. The Finance Department requests approval of the original Budget Ordinance for fiscal year 2024-2025 budget of the Piedmont Triad Regional Council. This original Budget Ordinance shows a total budget of \$47,827,353; a decrease of \$1,763,585 from the original Budget Ordinance for fiscal year 2023-2024. The following pages include the Budget Ordinance and a summary of the budget by area.
- b. The Finance Department requests approval of the original Budget Ordinance for fiscal year 2024-2025 budget of the Piedmont Triad Regional Council. This original Budget Ordinance shows a total budget of \$47,827,353; a decrease of \$1,763,585 from the original Budget Ordinance for fiscal year 2023-2024.
- c. Mr. Hand went over a summary of the changes for this year's budget. Those changes include:
 - i) A decrease in Admin due to the completion of the NCARCOG Resiliency/ Recovery Grant.
 - ii) Admin Services has 24 new projects ranging from \$3,300 to \$38,500.
 - iii) Crime Control will see a decrease to due to the transition of Project Reentry programs to the counties and the end of the current Recidivism Reduction Services in August.
 - iv) Aging is seeing a decrease due to ARPA coming to an end.

- v) Housing Rehab will increase with an addition of ESFR22 grants for seven counties.
- vi) Planning is receiving a NCDOT administered State Planning and Research grant in the amount of \$120,000 and \$66,000 in Clean Water funding. The budget reflects \$500,000 in 22 new Local Technical Assistance projects.
- vii) PTRDC shows a decrease due to several grants being finalized the previous year.
- viii) Section 8 will see an increase as more people are in the program.
- ix) WED shows a significant increase due to new grants from North Carolina Division of Workforce Solutions in the amount of \$785000. There are also increases in allocations for Adult and Youth Funding. Other funding includes \$500,000 in ARPA Workforce Based Learning, \$250,000 in ARPA Reentry Alamance, and \$35,000 in Business Services.
- d. Our three largest departments make up 82.51% of the budget. (AAA 36.02%, CD 26.98% & WED- 19.51%).
- e. Administration is 2.52% of budget.

- g. It is recommended that the board adopt this original budget ordinance of \$47,827,353 for fiscal year 2024-2025.
- h. Mr. Dolge thanked Mr. Hand and the entire staff for a great budget year. We worked with \$60million new dollars without hiring any additional staff. With the decrease we are seeing this year we won't have staff cuts. We feel strongly that this is a conservative budget and we will continue to serve you at the highest levels.
- i. Mr. Larry Phillips asked about the pay studies outside of the region. Mr. Dolge stated that our scope is much larger than that of other Council of Governments. Mr. Reece has expanded our Admin Services program by hiring retirees that have a great understanding of local government. Our services are stronger than those available in their areas. We feel it's important to strengthen not just our region but also the state when given the opportunity.
- j. Mr. John Larson asked how the budget reflects climate change and resiliency. Mr. Dolge answered that our Weatherization program is a large part of that. We aren't only weatherizing homes but also making individuals more self-sustaining. We have also developed a training program on energy efficiency techniques and have received a national certification.
- k. It is recommended that the board adopt this original budget ordinance of \$47,827,353 for fiscal year 2024-2025.
