CITIZENS INVITED TO REVIEW DRAFT TRANSPORTATION PROJECT LIST

KERNERSVILLE, NC, October 16, 2024 – Citizens in the Piedmont Triad Rural Planning Organization (PTRPO) area are encouraged to participate in implementing the [Strategic Transportation Investments](#) (STI) law. The STI law directs RPOs statewide to assign scores to local highway and non-highway mode projects considered important to their area. These local scores, when combined with a data-driven score, are used in determining the final point assignments for each project in the Regional and Division categories. Projects on the Statewide level are scored using data only.

For the next 14 days, the PTRPO is asking citizens in Caswell, Montgomery, Randolph, and Rockingham Counties to offer feedback on draft project scores in the Division category. A full listing of projects and their assigned scores can be found by visiting <http://www.ptrc.org/ptrpo>. Also available for viewing is the method the PTRPO developed to determine how to assign these points.
