Adult Services to administer the Community Resources Connection Initiative for the seven Eastern Counties for the period October 1, 2011 – June 30, 2012.

ITEM #: 1

In North Carolina funding has been available for several years to help people of all ages, disabilities, and income levels more easily access long-term services. This is federal funding provided by the Administration on Aging and the Centers for Medicare and Medicaid. Nationwide it is known as <u>Aging and Disability Resource Centers</u>. In North Carolina this initiative is called "**Community Resource Connections**" (CRC). Currently the PTRC AAA administers the CRC program development in Stokes, Surry and Yadkin. Forsyth County receives and manages its funding associated with the program. There is no programming in Davie at this time.

Alamance, Caswell, Davidson, Guilford, Montgomery, Randolph and Rockingham have been receiving funds as a consortium administered by Senior Resources of Guilford. The PTRC AAA has been asked by the members of this consortium to assume the administrative responsibility for program development.

The programs which are associated with the CRC include:

- 1. Information and Awareness
- 2. **Assistance**-options counseling-crisis intervention-benefits counseling
- 3. **Access**-eligibility screening-uniform access to programs
- 4. **Transitions**-Person Centered Hospital Discharge-Money Follows the person

As you know, the PTRC AAA is focused on broad planning and advocacy activities for older people within our planning and service area; we fund providers to deliver a wide range of community based services and directly provide information and referral as well as monitoring of 'residents rights' through our Long-Term Care Ombudsman program. We currently work with those agencies serving persons with disabilities. This is a major new component of the CRC program. These seven counties feel we can serve their needs better, at a lower cost and more consistently from the regional level.

It is the hope of AAA staff that in accepting this contract we can begin to look at including Davie and bringing all 12 counties of our region together on planning and accomplishment of the tasks associated with this funding.

Currently, the contract amount for CRC activities in Stokes, Surry and Yadkin is \$127,560. In accepting the administrative duties for the seven counties in the east it provides an additional \$135,655. These funds vary in their usage by county as you see below. Counties have the flexibility in their planning process to determine what works best in accomplishing the goals of the program.

Current Uses of CRC Funding

- Hosting low-income senior events for Medicare enrollment
- Provide health and wellness and prevention awareness events
- Implementation of Hospital Discharge Planning relationships to prevent re-admissions
- Develop local contact agencies to interview and support transition of eligible persons from Nursing Homes into the community
- Development of website with resource availability
- Collaboration with Community Care of North Carolina to identify Medicaid seniors who are may participate in health and wellness opportunities
- Pay for county coordinator to pull all resources together to accomplish the goals of the CRC
- Contract with professional to help in program start-up

Plans would include the hiring of a part-time coordinator to manage this program with existing AAA staff involvement.

I am requesting authorization to amend the contract with the Division of Aging and Adult Services to administer the Community Resources Connection Initiative for the additional seven counties in the eastern part of our region, bringing our programming to 10 counties for the period October 1, 2011 – June 30, 2012.
