 - Add YVEDDI representative as a voting member and add an Aviation representative
 - Change the TCC status of the following representatives to “ex-officio/ non-voting”:
Executive Director, NWPCOG; Chief Planner, NWPCOG; and NCDOT RPO Coordinator, Statewide Planning Branch
