 SPOTID# H090260 New Route from US 52 to US 311 should be removed from the STI list because the project is no longer feasible.
- b. Omission of SPOTID #H141623 and Re-Assignment of Surry County Local Priority Score

Based upon the recommendations of the TCC, **SPOTID# H141623** – Intersection of US 52 and US 601 should be omitted from the RPO's project list because the project is will be incorporated into the larger corridor project (**SPOTID# H141629** – US 601 from US 52 to Forrest Drive)

- c. Re-assignment of Yadkin County Local Priority Score
 Based upon the recommendations of RPO staff, Yadkin County requests the
 re-assignment of local priority scores to eligible Regional highway projects
 due to an error in the selection process by RPO staff.
- d. Issue with SPOTID #140443 at Division Level The cost to NCDOT of SPOTID #H140443: I-40 widening from US 601 toNC 801 is significantly higher than the annual amount allocated to Division 9. Based upon this issue, RPO staff is concerned that the project will not be successful at the Division level when another RPO project could be implemented.
