RE: Thomasville Land Use and Ordinance Development Phase II

The Planning Department requests to enter into contract for planning services with the following local governments in the upcoming fiscal year.

#### Phase 2 – Estimated Duration: 4 months; Estimated Cost: \$15,500

- Review zoning districts for the City of Thomasville and provide recommendations to the
  planning board for updating existing districts (especially M-1, M-2, C-1 to C-4) or adding
  new zoning districts (including conditional zoning districts) and revising the table of
  permitted uses, dimensions and setbacks for existing and new districts as necessary;
  and
- Review parking and landscape requirements and provide updated regulations based on planning board input.

Phase 2 Deliverables: a) Updated ordinance sections to include new districts, park and landscaping requirements; b) two workshops with staff, planning board or other stakeholders; c) two presentations on ordinance updates to the planning board and/or City Council; and d) complete updated ordinance document ready for web posting and printing.

The City of Thomasville has already approved the contracted amount.

The Northwest Piedmont Council of Governments and the Piedmont Triad Regional Council have been a lender for the Small Business Administration under their 504 Program for 33 years. During this time, we have made millions of dollars' worth of loans to small businesses, creating tax base for our member governments and jobs for the people of the region. Honoring this history, it is time for us to evaluate our current status with the program.

In the 504m program we partner with banks to provide bridge funding. Banks are the primary lender, and we provide the gap needed for good projects that may be slightly under capitalized. The key part of this relationship is the need for the banks to partner to make a project happen. The 504m Program provides community banks the opportunity to access SBA funds while not developing the infrastructure to administer them.

The banking environment has changed dramatically since the recession. Community banks have been acquired by larger banks. These larger banks have departments which package loans and access a different SBA program, the 7A Program. Banks get the fees for setting up 7A loans, and then can package these loans and sell them for additional profit. This has caused our 504 market to dry up.

SBA requires that all lenders approve 4 new loans a year to remain active. We have not met this threshold for 3 years. The Executive Committee needs to discuss whether we voluntarily close our program, or consider strategies to produce more traffic and loan activity.

Based Grants Initiative (CBGI)

I realize you are all working on plans for the \$1.5 million the Golden Leaf Foundation has allocated for economic development efforts in your county. Please read the attached letter for our proposal for a low interest low program to meet the need for access to capital for entrepreneurial and small business development.

The important highlights are that we can take a small portion of this money designated to each county, double it with Economic Development Administration funds, and alleviate the need for your county to generate match. Our experience as an SBA small business lender allows us to hit the ground running with a loan program that can be focused toward your goals.

A further positive is that once we match this first EDA investment, we can request more funds to recapitalize the program with no further match required.

I know you have many needs and likely already have more requests than funding. I would not make this proposal if it did not meet a known need, and offer a long-term, self-sustaining response. As always, PTRC values your partnership and I welcome your thoughts.

Re: Request for Support of the FY 2017 Golden Leaf Foundation Community Based Grants Initiative (CBGI)

The Piedmont Triad Regional Development Corporation is creating an *Investment Fund* to address quality job creation, small to large business and entrepreneurial support, redevelopment, housing and community infrastructure, in all 12 of the PTRC counties.

The capitalization of the fund includes an application to the Economic Development Administration (EDA) for a \$1,000,000-\$2,000,000 revolving loan fund (RLF), which requires a one-for-one local match to capitalize the program.

It is requested that you consider supporting this effort through the Golden Leaf CBGI program, which has a pre-proposal deadline of September 30, 2016. Support through your County of \$100,000 for the Piedmont Triad based fund would assist the PTRDC in applying for the EDA revolving loan fund. The 20% match requirement for Golden Leaf would be satisfied through a request for funds from the EDA. Future match for the revolving loan fund will not be required after successful loans have been completed and closed out.

Supporting the PTRDC and its application to the FY 2017 Golden Leaf Foundation's CBGI will help to create funding sources based in the Piedmont Triad region for community and economic development. The revolving loan fund intends to prioritize lending that supports our existing downtowns and developed areas where infrastructure currently exists, creating a good return on investment for Piedmont Triad member governments and the communities in which our residents live, work and play. As part of the *Investment Fund* development, we invite you to provide input to the PTRDC on how to select, prioritize and underwrite projects that benefit your community. Capacity for the RLF will be provided through our current SBA loan program and loan committee of the PTRDC.

Please consider this request as you prioritize projects for inclusion on the Golden Leaf Letter of Inquiry (LOI) for your County. If agreeable to this proposal, we can provide the required LOI for the preproposal submission.
