RE: Request for authorization to apply for rehabilitation funding from North Carolina

Housing Finance Agency (NCHFA) for Guilford and Davidson Counties

The PTRC applied for and was awarded the 2014 NCHFA Single Family Rehabilitation Loan Pool (SFRLP14) grants for both Guilford and Davidson counties. The individual county grants were originally for \$170,000, for three houses, and by utilizing the NCHFA Pool 10 units have been either completed or are underway in Guilford County with 9 units in Davidson County. The SFRLP14 grants must be fully closed out by June 30, 2017.

The applications for the 2016 NCHFA Essential Single Family Rehabilitation Loan Pool (ESFRLP16) grants for both Guilford and Davidson counties are due December 9th 2016. The new ESFRLP16 grants are different from the SFRLP14 grants in that they are limited to \$25,000 per home, SFRLP14 was \$45,000 per home, and homeowners in the City of High Point are now eligible for participation which was not the case with the 2014 grant.

PTRC Housing Department staff is requesting that the PTRC Board approve the PTRC applying directly for ESFRLP16 funding in Guilford and Davidson Counties.

For reference, verbiage from the Bylaws regarding officers can be found below.

Article II. Officers

Section 1. Officer Positions

The officers of the Piedmont Triad Regional Council shall consist of a Chair, Vice-Chair, Treasurer, and Secretary, all of whom are to be selected from among the Council members. Appointment of Immediate Past Chair to serve as an ex-officio of the nominating committee. <u>Section 3 Terms also defines the qualifications and eligibility of delegates to serve as officers.</u>

Section 2. Annual Election of Officers

The current officers, along with four additional Executive Committee members appointed by the Chair, will present a proposed slate of officers to the Executive committee for their approval. The Executive Committee will present their nominations annually at the regular December meeting, which shall be considered the annual meeting of the Council.

ACTION ITEM #3 CONT.

Section 3. Terms

The officers shall serve for one year or until their successors have been duly elected. The officers, starting with the Chair, must alternate being a Delegate of a county or municipal government. Delegates in contiguous officer positions must come from different counties. An officer may not serve more than two consecutive one-year terms in the same office. Eligibility to hold a Council office shall be a minimum of one year as a Council Delegate.

Section 4. Duties of Officers

- A. **The Chair** shall preside at all meetings of the Council and shall conduct meetings in an orderly and impartial manner so as to permit a free and full discussion by the Delegates of such matters as may be brought to the Council. The Chair shall have the same voting rights as other Delegates. The Chair may appoint such advisory committees as he/she finds to be necessary or desirable.
- B. **The Vice-Chair** shall perform all the duties of the Chair in the absence of the Chair, or in the event of the inability of the Chair to act, and shall perform such other duties as the Council may delegate.
- C. **The Treasurer** shall review the financial transactions of the Council, including the audit, prior to the audit's presentation to Delegates, and shall perform such other duties as may be prescribed by the Council or by the Chair.
- D. **The Secretary** shall review all minutes of the Council, and shall perform such other duties as may be prescribed by the Council or the Chair.

RE: Golden LEAF Investment Fund and EDA Revolving Loan Fund Full Proposal

The Piedmont Triad Regional Development Corporation (PTRDC) submitted a letter of inquiry to match funding for an Economic Development Administration revolving loan fund application which would capitalize a Piedmont Triad based Investment Fund. As part of the CBGI program of Golden LEAF for 11 of the 12 PTRC counties, the request was submitted for \$1,000,000 to capitalize half of the \$2,000,000 initial revolving loan fund amount. The PTRDC has been invited to submit a full proposal to Golden LEAF due on **January 20, 2016**. Jointly, an Economic Development Administration revolving loan fund application will be requested for the other \$1,000,000 in initial capitalization of the fund in January, but this is a rolling deadline. Each funding source will match the other 50% as required by the granting agencies.

The Investment Fund when fully implemented would be used to address job creation, small business and entrepreneurial support, redevelopment, housing and community infrastructure. The investment fund overview information was provided in past meetings but is attached here for reference.

Community Investment Fund Overview

It is proposed that the Piedmont Triad Regional Development Corporation (PTRDC) create a community and economic development *Investment Fund* to address job creation, small business and entrepreneurial support, redevelopment, housing and community infrastructure. This program will be a catalyst to leverage public and private investment resources, including allowing local regional and national banks to pool their CRA funding, to increase the number and magnitude of high impact community development projects in all 12 counties.

Over the past two decades nearly half (90,000) of our region's manufacturing jobs have been lost, negatively impacting the fiber of both small and large communities throughout our region. This program will be focused on civic priorities to provide assistance to self-motivated communities. Emphasis will be placed on planned redevelopment districts in communities throughout our region, bringing targeted resources for Economic Development, Small Business loans, Workforce Housing Development and other impact investment projects.

The (PTRDC) will administer the fund and utilize the regional reach of the Piedmont Triad Regional Council (PTRC) to identify then incentivize aggressive job creation, workforce housing development, community engagement and improvement of the living conditions for residents in pre-qualified areas, focusing on low income communities and their well-being. We will work with all private funding sources to insure that projects in which they participate meet their broader goals. This program will provide the critical mass of funding needed to make the highest impact possible for our member communities and partners.

As a starting point, we are proposing a CRA Community and Neighborhood Reinvestment working group be developed to create this unique entity. Economic Development CRA investments lag behind Housing Development and individual assistance to low income people nationally. In contrast to this, our fund will be structured to expand job opportunities for at risk residents as well as reinvest in quality workforce housing, downtown and community redevelopment and strong neighborhoods.

All of the projects will be selected based on criteria to deliver high impact that go beyond the direct investment. The *Investment Fund* will promote sustainable, equitable and livable communities, leveraging other State, local and federal funding to improve employment, transportation and affordable housing opportunities for local residents. Our goal will be to make investments consistent with community and board priorities in support of local efforts to revitalize surrounding neighborhoods, retain current residents, increase access to greenspace and healthy food, increase tax base and access to public services, and provide equitable opportunities and a higher quality of life for all citizens.

ACTION ITEM #5 CONT.

Community Investment Fund Capacity and Reach

Since 1983, PTRC staff has administered a 504 Small Business Loan Program, and has an experienced loan committee in place that has approved 87 debentures totaling \$32 Million and creating an estimated 1,341 new jobs. A Regional Brownfields Program has identified and funded environmental assessments on dozens of sites since 2013 totaling over \$500,000, facilitating re-development of former mill or manufacturing sites where pollution may inhibit re-development or land sale. The Housing Program has administered the Surry HOME Program since 1993. Since 1993 over \$12 Million has been invested in over 500 HOME units (over 1,000 total units) of affordable housing including new rental properties, housing rehabilitation and single family home development. In addition staff administers annually a \$3 Million Housing Voucher Program serving 800 low income elderly and disabled households and through the NCHFA (NC Housing Finance Agency) oversees the remodeling of approximately 40 substandard houses annually in 6 counties.

The Piedmont Triad Regional Council has experience and expertise necessary to successfully manage and develop the Community Investment Fund. Working closely with the Piedmont Triad Regional Development Corporation (PTRDC), which consists of public and private sector members in the 12-County Piedmont Triad, PTRC staff will develop criteria and processes that prioritize projects in low to moderate income communities across the diverse Piedmont Triad Region. Using GIS analysis, socio-economic indicators and areas of impact can be highlighted at the neighborhood, community, municipal or County scale depending on the scope of the project and the approach.

Housing Programs: Substantial single family rehabilitation (SFR), Urgent Housing Repair, Affordable Housing Development, Section 8 Rental Assistance, construction management and grant administration

Weatherization Assistance: Weatherization for low to moderate income tenants or home owners

Planning Programs: Brownfield assessments, Brownfield revolving loan fund (requested from EPA), Strategic planning, Recreation and site planning, GIS mapping and analysis of socioeconomic factors

Workforce Development: Workforce recruitment, Mobile Job Link Center, Workforce training and counseling

RE: NC DEQ 205(j) WQ Management Planning Grant Proposal

The Department of Environment and Natural Resources Division of Water Resources has additional funding available for Fiscal Year 2017 and requested the Piedmont Triad Regional Council Planning Department submit a proposal. The Planning Department is requesting funding to implement recommendations from "Climate Adaptation in North Carolina's Piedmont Triad Region," a report compiled as part of Piedmont Together, a HUD Sustainable Communities initiative. This report addresses a number of issues to decrease the Piedmont Triad's vulnerability to climate change, including protecting the region's water supply and quality.

If funded, the project will target and identify resilience strategies to mitigate changing weather patterns which can decrease river and lake water quality in many ways, including increases in sediment, nitrogen, and other pollutant loads. Changes in precipitation and runoff, combined with changes in consumption and withdrawal also increase the likelihood of water shortages for many users and may also result in increased flooding.

The PTRC Planning Department is requesting \$20,000 in funding. 205(j) proposals do not have a match requirement.

RE: Caucus Procedure 2017

The Executive Committee is composed of one delegate from each county, one delegate from any municipality with 50,000 or more in population, and one municipal delegate from each county representing municipalities under 50,000. The Executive Committee is authorized to act for the Council on all matters other than the adoption of the annual budget and the adoption of the annual program of work. The Executive Committee meets 10 times per year (every month except January and July) and may conduct all the business of the Council in the months the full board does not meet.

According to Article III Section 2, regarding the composition of the Executive Committee, it is necessary for caucuses (for municipalities under fifty-thousand in population) to be held for the purpose of selecting a delegate to represent each county. In order to be on the Executive Committee, members need to be available to meet up to sixteen times per year, which will be six board meetings and ten executive committee luncheon meetings.

Caucuses will be held for Alamance, Davidson, Davie, Forsyth, Guilford, Montgomery, Randolph, Rockingham, Stokes, Surry and Yadkin.

This year we propose to hold the caucuses electronically via email primarily. You will receive an email on January 12th. You will be asked to respond by January 19th. If you would still like to discuss it further we will set up the teleconference line for a teleconference on January 19th.

Action Requested: Approval for the 2017 municipal caucus to be held electronically via email and phone as necessary and according to the schedule provided.
