RE: Local Technical Assistance Contracts

The Planning Department requests to enter into contract for planning services with the following local governments in the current and upcoming fiscal years.

#### **Downtown Stoneville Pocket Park: \$11,000**

Assist with survey development, site specific design and public involvement for the proposed Downtown Stoneville Pocket Park. The contract also includes a sub-contract with Foothills Planning and Design in the amount of \$7,500 to assist with project deliverables. The project is estimated to be completed by September 2017.

#### **Surry County Land Development Plan Update: \$44,750**

The land development plan update will begin in June 2017 and continue through to the summer of 2018. The following summary of the scope of work describes the project deliverables.

- 1. Review and update existing conditions to reflect growth since the last LUP, including text and map edits to water and sewer service areas, voluntary agriculture districts, rural growth areas and corridors, cultural features, development limitations, land use, and transportation projects.
- 2. Facilitate public meetings, public input relating to land use plan recommendations and updates.
- 3. Recommend policy changes in response to recently adopted plans, trends in activity center or rural growth corridor development, municipal growth, changes in general statutes and other issues related to land development issues.

# Town of Mocksville ABC Store Feasibility Study: \$8,500 Feasibility Study Scope:

- 1. Demographic and Retail Study: Collect and analyze Town demographics and retail preferences and compare market for ABC sales with other jurisdictions of similar size.
- 2. ABC Board Analysis: Estimate the operating costs for a combined Cooleemee ABC board and a stand-alone board.
- 3. Site Selection Analysis: Collect and analyze land use, zoning, AADT and cross reference with available land to determine a ranked list of potential parcels.

#### Town of Summerfield UDO Committee Facilitation Services: \$9,995

Services provided in partnership with McNeil Planning Solutions will include up to 9 months of assistance facilitating twice monthly UDO committee meetings with an associated agenda conference call; progress updates every two months to Town Council and a summary of recommendations.
