 - Complexities what is talked about in communities and by communities versus what is being discussed at meetings for solutions

- Especially for new councils See what is possible, see a range of food councils in their development; at first is about so much stakeholder involvement, this isn't addressed as much and so much need to work on who wants to be involved
- o From evaluations how many times a year do folks want to meet?
- What are any takeaways? Anything we want to do after what we learned?
 - Potentially thinking about this as litmus test for statewide gathering
 - Rockingham County needs moral support
 - Opportunity to review the Community Food Snapshot card
 - Surprised by lack of Cooperative Extension participation
