- How
 - Technical writer review and edit
 - QA review and edit
 - Ambient Monitoring Program & Chemistry Section staff
 - Legal review
- Results
 - Updated, streamlined, electronically friendly
 - MOA template created for other coalition MOAs

What is changed: Basic Updates

- Dates
- Grammar
 - "between vs among"
 - Coalition Coordinator is a proper noun and therefore capitalized
- Style and Format
 - Restructured
 - i.e. Headers established, blank pages removed
 - Reformatted into Word 2016
- Names Updated
 - Signature authorities
 - Facility changes
 - Department of Environmental Quality, Division of Water Resources
- Tables & Appendices restructured/updated/relabeled
 - Table 1 and Signature page combined
 - Table A: Sampling Stations, Parameters and Frequency= Table 2
 - i.e. Hardness, Stream index, station comments
 - Table B-1: Reporting limits = Table 3
 - hardness added
 - Table B-2: Remark codes = Table 4
 - updated
 - Table C: Data Reporting=Table 5
 - "Example" of a format
 - unused columns removed (does not effect data submittal)

What is changed: Requirements

- Removed the requirement that "DWR issues a letter to <u>each</u> of the Permittees notifying them that the instream monitoring requirement are waived as long as they are a member of the Coalition"
 - One letter issued to the chair to be distributed electronically.
- Data/reports should be sent to the <u>coalitioncoordinator@ncdenr.gov</u>
- Annual report requirements
 - past amendment incorporated into new document

What is changed? Important Notes

Clarifications

- The MOA is among DWR, the UCFRBA and the UCFRBA members.
- Waiving of instream requirements only applies to certain parameters "as specified in their individual permits"
- Withdraw/Termination as between DWR and individual UCFRBA Permittees.
 - Become effective upon the termination date specified in the notice

Text changes

- Metals and hardness
 - NOT BEING REQUIRED BY THE COALITION AT THIS TIME BUT.....
 - May be part of NPDES permit (i.e. Duke Energy Facilities)
 - May choose to collect if an NPDES permit requires (i.e. hardness)
- Additional data collection MAY BE REQUESTED should specific issues arise.
 - Emerging contaminants opener

What is changed? Important Notes cont...

- Text Changes cont.
 - "Each UCFRBA PERMTTEE has the right to review and comment on work, data, or reports prepared by any contractor on behalf of the UCFRBA PERMITTEES and notify the DWR of any objection or disagreement with any portion of the work, data or reports"
 - now reads
 - "The UCFRBA PERMITTEES may provide comments to DWR on data and work submitted by the UCFRBA to DWR".
- Text additions
 - No limitation on use of the data:
 - Applies to DWR, UCFRBA and Permittees
 - Savings Clause:
 - Should any part of this agreement be declared invalid.....
 - Remedies for Breach:
 - The only remedy for breach is an action for specific performance or injunction.
