Meeting Notes

Welcome & Introductions

• Mr. David Putnam and Mr. Jesse Day provided welcoming remarks and facilitated 2-minute introductions with the Food Council.

Regional Food System Proposal Process

- Mr. Day and Mr. Putnam shared a review of the RFP process.
- The review elements of the RFP process involved describing the initial proposal count and review sub-committees recommendation, the RFP scorecard, the RFP responses from the two recommended firms, and introducing the RFP interview of the two recommended firms on Wednesday, September 11th.
 - A request was made for attendance of available board members at this September 11th meeting.
- Mr. Day and Mr. Putnam facilitated small group discussions to develop important questions for the September 11th meeting.
- Key questions that were revealed:
 - o How will you mitigate trust barriers?
 - o What is your experience with diverse populations?
 - What practical deliverables will impact change?
 - o How do you plan to engage communities?
 - Can you please describe your ability to translate and communicate through language barriers?
 - What is the capability of your team to assist with assessment recommendations? After the one year contract?
 - Describe your team's prior working relationships?
 - o What are your best examples?
 - What was one of the most innovative projects you were involved with and what did you learn?
 - How will you assure an equitable collection of data from all our areas?
 - What is the strategy for reaching our rural population versus urban populations and all areas of our region?
 - Will you create profiles or roadmaps for each county and the overall region?
 - O How do you envision getting to policy changes in our area?
 - o How do you define equity?

- How do you plan to access the most appropriate data for this project, beyond secondary, public data?
- o How do you plan to incorporate qualitative, and non-traditional types of data?
- o What is your plan for getting disaggregated data?
- o What is your plan for a final presentation/product of the assessment?
- How do you plan to make this a document that is used and accessible to the community?
- What experience do you have working with different sectors, different groups of people, and determining what is most important to them to make your work meaningful and applicable?
- o In your experience, what do you think is the most important lever to pull in creating a liberating and just food system?
- o How is this project unique from your past projects or work?
 - How will we know that you are not just using a template?
- Please share how you are going to clearly define the roles and distribution of work amongst your staff on the project.
- What do you think will be the greatest challenge of this work? Tell us about a challenge your firm experienced in a previous food system assessment, and what you did to overcome it?
- o How can we as the regional food council best support you when challenges arise?

Governance, Structure, and Representation

- A 15-minute presentation was provided by the Governance and Structure sub-committee of Mr. Tom Henslee and Ms. Hannah Harrison.
- The presentation recommended that the PTRFC adopt organizational structure elements such as:
 - Co-chairs the PTRFC leadership should be represented by two Co-chairs, and Co-chairs are recommended to be elected the start of next year (January 2020).
 - Committees -- should be formed by a strong interest and must be voted on by PTRFC.
 The Coordinator shall be a non-voting member but will help collaborate between
 committees. Committees will have a minimum of 3 members and report to the PTRFC
 when applicable. These committees will also choose their own tool for efficient
 communication.
 - Co-chair responsibilities add support coordinator when questions or decisions come up; review the monthly meeting agenda with the coordinator prior to the meeting; organize and motivate workgroups, stakeholders, and community involvement. Remove the elements of responsibilities that conflict with coordinator responsibilities.

Racial Equity Discussion

- Mr. Gary Williams lead a discussion of racial equity and introduced the REI group based out of Greensboro.
 - Interest for a subcommittee focusing on Racial Equity was present.
