II. Yadkin County Pedestrian Planning Grant Resolution Sarah Harris

III. P 6.0 Project Draft Submission List Jesse Day

Mr. Day reviewed the meetings conducted with each County to discuss top priority projects. The following meetings were held in July: Yadkin County – 7/16/19; Stokes County - 7/18/19, Surry County 7/23/19 and Davie County – 7/25/19. The draft project list resulting from that meeting was distributed and discussed. It consisted of 23 highway projects (21 possible submissions for each mode in P6.0), 9 bike and ped projects and 5 airport projects. It was mentioned that some

Elkin priority projects needed to be added to the list. In addition, discussion of modifying the committed project R-5912 - a roundabout at Old US 421 and Falcon Road took place. It was mentioned that this might be better served as a signalized intersection, but that may jeopardize funding. Ms. Hughes asked if discussion of a possible airport should be included in the P 6.0 discussion. The airport was preliminary, but it was suggested that the County Commission pass a resolution to begin the process of evaluating resources available for the airport.
